

of the said school as described below:-


1. The name of the Trust shall be called



- a) The author himself has also donated Rs 10,000/- to the ~~trust board~~- fund of the said Nayas as preliminary fund.
- b) The Nayas can raise funds by funds collected through subscription from public persons interested in the well being and promotion of the Trust and its objectives and also from donations and grants from individuals, government & non-government grants and through other fund raising programmes.
- c) The Nayas may raise funds by borrowing money with or without interest from Banks or any financial institution and the same will be returned on per the terms and conditions of the loan as duly resolved and decided by the managing committee.

5) Bank Account and operations

The funds of the Nayas will be deposited and kept in a bank named by the said committee under the said operating system. The Nayas accounts shall be operated only by any two of the chairman, secretary and the treasurer.



9) Audit of Account

The auditors appointed by the managing Committee will audit the annual account and his report would be placed in the annual meeting of the managing Committee for scrutiny and necessary orders—

10) The funds and money & income of the Naivas can't be utilised for the following purposes:—

a) for acquiring property (movable & immovable) for the purpose and object of the Naivas.

b) for payment of salary of the fund staff of the Naivas

(b) The secretary of the Hays shall be the
convener of the meeting and he shall duly

date fixed for the meeting.

(c) The secretary shall maintain the agenda
book containing the re-solutions to be
proposed at the meeting called for consideration.

(d) The resolution of the meeting shall be
passed unanimously or by majority of
the votes of the members present.

(e) The presence of at least five members
will be sufficient to constitute a quorum.

(f) All resolutions so passed shall be
deemed to be valid and shall be carried
as far as possible.

(g) The author aforesaid shall be the life
member of the Hays committee and he
shall be the ex-officio secretary until
he voluntarily resigns or becomes mentally
and physically incapable & abores.
