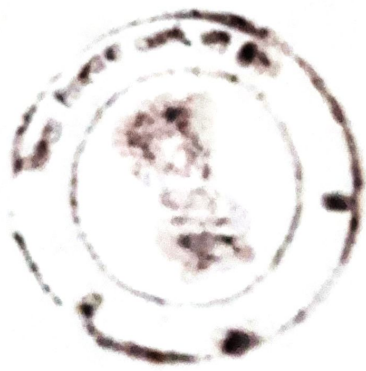

## 2) Funds: —

a) The author proposed has also donated Rs 10,000/- to the ~~(Trust)~~ fund of the said Nayas as preliminary fund.

b) The Nayas will be run by funds collected through subscription from Public Persons interested in the well being and promotion of the Trust and its objectives and also from donations and grants from individuals, government & non-government grants and through other fund raising programmes.

c) The Nayas may raise funds by borrowing money with or without interest from banks & any financial institution and the same will be returned on per the terms and conditions of the loan as duly resolved and decided by the managing committee.

## 3) Bank Account and operation —

The funds of the Nayas will be deposited and kept in a bank named by the said committee under the joint operation system. The Nayas accounts shall be operated only by any two of the Chairman secretary and the Treasurer.





## 9) Audit of Account \_\_\_\_\_ (2)

The auditors appointed by the managing committee will audit the annual account and his report would be placed in the annual meeting of the managing committee for scrutiny and necessary orders—

10) The funds and money & income of the Nayas will be utilised for the following purposes:—
